The Mandator hereby grants to the Mandatary a power of attorney in order to represent the Mandator and to act on his/her behalf **in legal actions** with the bank: Tatra banka, a.s., with its registered office at Hodžovo námestie 3, 811 06 Bratislava I, Reg. No.: 00 686 930, registered in the Commercial Register of the Bratislava I District Court, Section: Sa, Insert No.: 71/B (hereinafter referred to as the „Bank“), to the following extent:

1. conclusion of and amendment to any current account contract, term account contract, passbook contract,
2. disposal of funds in the Mandator's account and/or passbook in the Bank, independently and without restriction, and appointment of persons authorised to dispose of the Mandator's account and/or passbook,
3. closure of any account and/or passbook of the Mandator in the Bank and takeover of the balance from such closed account and/or passbook,
4. requesting information about the Mandator which the Bank is disposing of, also in cases when the information is protected under special legislation,
5. submission of an application for the issuance and/or cancellation of a debit payment card issued in the name of the Mandator and its takeover, return of protection passwords and codes (e.g., PIN code, etc.) for the cards,
6. performance of all tasks necessary to make it possible to use banking services for the account by means of electronic communication media, disposal of funds in the Mandator's account by means of electronic communication media, and the appointment of persons authorised to dispose of the Mandator's account, including the conclusion of, amendment to and termination of any contract of ancillary services provided to the account by means of electronic communication media, in compliance with the Business Terms and Conditions of Tatra banka, a.s., for electronic banking.
7. conclusion of, amendment to and termination of a Contract of Services provided by means of Business Banking^{TB} Electronic Banking, disposal of funds in the Mandator's account by means of the Business Banking^{TB} service, independently and without restriction, and the appointment of Users in compliance with the Business Terms and Conditions of Tatra banka, a.s. for the services of the Business Banking^{TB} Electronic Banking.

On the basis and within the scope of this power of attorney, the Mandatary is entitled to grant a power of attorney to another person in order to act on his/her behalf for the Mandator, and if several persons have been appointed, each should act independently.

The power of attorney is granted for an indefinite period.
