The Mandator hereby grants to the Mandatory a power of attorney to **any legal actions related to the provision, repayment and change of any loan, where, acting as the creditor in a loan agreement, there is Tatra banka, a.s., Bratislava**, with registered office at Hodžovo námestie 3, 850 05 Bratislava 55, Reg. No.: 00 686 930, registered in: the Commercial Register of the Bratislava I District Court, Section: Sa, Insert No.: 71/B (hereinafter referred to as the „Bank“), primarily to:

1. submit an application for a loan or an application for a change in the loan, submit documents related to the application, perform any tasks and sign any documents necessary for the preparation of contractual documentation, while the Mandator declares that he/she knows the content of such application and that he/she is aware of any declarations and consents, which he/she will grant to the Bank by signing the application,
2. sign a loan agreement, including its appendices, and arrangements of all provisions, primarily the terms and conditions for the granting and repayment of the loan, its amount, maturity and purpose of the loan, including possible addenda or amendments,
3. carry out legal actions related to the opening and disposing of any account of the Mandator in the Bank, primarily to:
  - a. conclude and amend any ancillary banking services contract for the bank account, in particular an Identification, Authentication and Authorisation Means Agreement, including taking any related steps, in particular the takeover of the authorisation and authentication tools,
  - b. take over a payment card, including protective passwords and codes (e.g., PIN code, etc.) for the card,
4. conclusion of an insurance policy, including its appendices, related to a mortgaged property, which is the subject matter of a loan security, namely an insurance policy with the possibility of valorisation for the sum insured at least in the amount of a new (baseline) value determined by the insurance company if the mortgaged property is a family house, or for the sum insured at least in the amount of the market value determined by the insurance company if the mortgaged property is a flat,
5. sign other contracts and documents relating to the provision, repayment, and any change of the loan.

On the basis and within the scope of this power of attorney, the Mandatory is entitled to grant a power of attorney to another person in order to act on his/her behalf for the Mandator.

The power of attorney is granted for an indefinite period.
