



Conditions of the “Roadshow Pepper^{TB}” competition

1. „Pepper^{TB}“ competition (hereinafter referred to as “competition”) takes place from December 3, 2018 till March 3, 2019 - 23:59 hrs. (hereinafter referred to as “duration of the competition”) during the presence of the humanoid robot Pepper at the Tatra banka branches:
 - in the shopping centre **Bory Mall**, Lamač 6780, 841 04 Bratislava in the period from December 3, 2018 till January 3, 2019,
 - in the shopping centre **Aupark**, Einsteinova č. 18, Aupark II., 851 01 Bratislava in the period from January 11, 2019 till February 11, 2019,
 - in the shopping centre **Polus City Center**, Vajnorska 100, OC Central, 831 04 Bratislava in the period from February 12, 2019 till March 12, 2019(for individual branches hereinafter collectively referred to also as “branch”)
2. The organizer of the competition is Tatra banka, a.s., registered office at Hodžovo námestie 3, 811 06 Bratislava 1, Organization ID: 00686930, registered in the Bratislava I District Court Companies Register, Section Sa, Insert No. 71/B (hereinafter referred to as “organizer of competition” or “Tatra banka”).
3. The **prize** in the competition are three robots, OZOBOT, BIT 2.0 titan black, valued at EUR 55 excl. VAT (hereinafter referred to as “Prize”).
4. To participate in the competition the following conditions must be fulfilled:
 - a) the competitor has an **Instagram profile**;
 - b) the competitor will take a photo with robot Pepper at the branch during the period of competition;
 - c) During the period of competition, the competitor will **send** the picture made according to letter b) **to their Instagram profile** with the name of **#peppertb in the form of an Instagram post (not as Instagram stories)**.
5. Out of all the competitors that fulfilled the conditions according to the point 4 of the conditions of competition hereof the organizer will **draw three (3) winners on March 4, 2019**. Each winner will get one robot OZOBOT according to the point 3 of the conditions of competition hereof.
6. The organizer of the competition will contact the winner through message under the Instagram post named #peppertb. The organizer of the competition will present the prize to the winner within 10 working days from the day of the draw according to the point 5 of the conditions of competition hereof unless otherwise agreed with the winner.
7. In the event the winner does not collaborate with the organizer of the competition within 2 days from the notification by the organizer of the competition, the winner loses their right to the prize and the organizer of the competition is entitled to draw another winner. In the event the winner declines the prize, the winner loses their right to the prize and the organizer of the competition is entitled to draw another winner. In the

event the organizer fails to contact the winner, the winner loses their right to the prize and the organizer of the competition is entitled to draw another winner.

8. By their participation in the competition the competitor expresses their consent with the the conditions of the competition.
9. It is not possible to exchange the prize for cash or other settlement.
10. For the purposes of ensuring the execution of the competition and evaluation of its results the personal data of the competitors in the extent of name, surname, phone number, Instagram name and email address shall be processed by the organizer of the competition as a controller. The legal grounds for the processing is Art. 6 (1) b of the Regulation of the EP and Council (EU) 2016/679 from April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, which means that this processing is inevitable for the performance of the contract (in relation to the participation in the competition).

 - Personal data shall not be provided to the third persons except for the case when the duty of the organizer of the competition to provide personal data follows from the applicable legal regulations
 - In case the purpose of the processing has been fulfilled the personal data of the competitors shall be stored only for the period of 1 year necessary for the protection of the rights and legally protected interests of the organizer of the competition.
 - The competitor has the right to request from the organizer of the competition the access to the personal data related to their person, the right to correct the data, their deletion or restriction of processing and right to transfer the data.
 - The competitor has the right to file a complaint to the Office for Personal Data Protection of the Slovak republic.
11. The organizer of the competition is entitled to exclude the competitors who do not fulfil the conditions of the competition, violate the conditions of the competition or shall act contrary to good morals.
12. The organizer of the competition is not responsible for any technical problems that may arise during the transfer of the data by electronic means nor for potential problems related to functionality of Instagram social network.
13. The organizer of the competition reserves their right to modify these conditions of competition and to extend or early terminate the duration of the competition.
