## **Public Pledge**

valid from 17 August 2021

to extend the scope of medical expenses insurance and cancellation fee insurance (tours, booked foreign trips/travel tickets) in travel insurance

This **Public Pledge** of UNIQA poist'ovňa, a.s., (hereinafter also referred to as the "Insurer") to extend the coverage of the General Insurance Terms and Conditions for Travel Insurance for Tatra banka clients - VPP CP-TA and coverage of the General Insurance Terms and Conditions for Travel Insurance for Tatra banka clients payment cards – VPP CPPK-TA is addressed to any individual person who has a valid travel insurance policy with the Insurer (hereinafter also referred to as the "Insured").

## 1. Extension of the subject of insurance

- 1.1. The subject of the medical expenses insurance are the demonstrable costs incurred by the Insured for necessary medical treatment abroad in the event of acute illness, and also covers the reimbursement of costs in connection with COVID-19:
- a) the costs incurred by the Insured abroad in connection with the COVID-19 disease are covered up to the limit of medical expenses, even in countries where is not recommended to travel and which have not been designated as safe by the Ministry of Foreign and European Affairs of the Slovak Republic (hereinafter also referred to as the "MZV SR") due to the unfavourable epidemiological situation (countries and regions with the third degree of recommendation recommendation of MZV SR not to travel abroad).
- b) in the event of a positive test result for COVID-19 abroad and subsequent compulsory quarantine, the Insurer shall cover costs of accommodation up to a sum of EUR 100 per person per day, but a maximum of EUR 1,500. The Insurer will only cover the costs of the imposed quarantine if they have not been reimbursed by the authorised local authority abroad.
- 1.2. The subject of the trip/tour/travel ticket cancellation insurance are the costs related to the cancellation or rebooking of the trip/tour (accommodation), or travel ticket. Cancellation insurance is extended to cover the cost of cancellation charges in the event of a positive test result (RT-PCR test) for COVID-19 before the trip abroad and the subsequent compulsory imposition of home quarantine on the Insured. The insurer covers the cost of cancellation fees up to the limit specified in the insurance policy. Cancellation fee insurance is not applicable in situations where the Insured has been placed in preventive home quarantine without the disease having been confirmed.

## 2. Validity and effectiveness of the Public Pledge

This Public Pledge is effective during its validity period for all insured persons of every travel insurance policy for clients of Tatra banka and for every travel insurance policy concluded to the payment cards of Tatra banka clients which is valid and effective during the validity period of this public pledge.

The Public Pledge is published on the Insurer's website. This Public Pledge shall come into validity and effect on 17 August 2021 and shall be valid and effective for as long as it is published. It shall apply to claims arising during its validity. In the event of a claim under this Public Pledge, the Insured shall comply with the Insurer's instructions.

UNIQA poisťovňa, a.s. reserves the right to amend or revoke this Public Pledge at any time, whereas the claims of the insured persons arising during its validity shall remain unaffected.
